The Lake Chad Basin Commission (LCBC) has received financing from the African Development Bank toward the cost of the **Investment Planning for Climate Resilient Socio-Economic Growth in the Lake Chad Basin (PIBALT)** and intends to apply part of the agreed amount for this grant to payments under the contract for development of a five-year investment plan for the Lake Chad Basin Commission (LCBC).

The services included under this project are (1) Evaluation of the implementation of the first SAP of the LCBC and (2) Preparation of the second Five Year Investment Plan (FYIP).

The duration of the service is seven (07) months from the date of notification of start of the service established by the Project Coordinator.
