CALL FOR PROPOSALS

Recruitment of National Consultants to Support the Update of the Territorial Action Plans (TAPs) in Cameroon, Niger, Nigeria, and Chad, and the Preparation of the Results Framework of the Adjusted RS SRR

The Lake Chad Basin Commission (LCBC) is a regional organisation comprising Cameroon, Niger, Nigeria, Chad, CAR and Libya. Its mission is to promote cooperation among Member States for the equitable and sustainable use of the national resources of the Lake Chad Basin for economic purposes and to assist in resolving disputes.

The Lake Chad Basin Commission (LCBC) adopted the Regional Strategy for the Stabilization, Recovery and Resilience of the Boko Haram Affected Areas of the Lake Chad Basin Region (RS SRR) in August 2018 to respond to the security and development challenges in the four countries surrounding the Lake Chad (Cameroon, Chad, Niger and Nigeria). The Regional Strategy was further endorsed by the Peace and Security Council of the African Union (AU-PSC) in December 2018. These two milestones signified regional and continental acceptance of the Regional Strategy as the overarching framework for stabilising the region and transitioning to recovery and longer-term peace and development. At the 4th Steering Committee meeting in September 2023, recognizing the progress that had been made and the challenges that still exist, the LCBC was tasked with leading the process of preparing an adjusted Regional Strategy. The LCBC was mandated to ensure that the adjustment process employed an inclusive and consultative approach. The adjusted Regional Strategy was technically validated in September 2024 and adopted by the LCBC Council of Ministers in February 2025.

The implementation of the RS SRR is localized in the Governors' Offices of each affected territory through the Territorial Action Plans (TAPs). There are eight TAPs, one for each of the affected territories (Borno, Adamawa, and Yobe states in Nigeria; Far North and North regions in Cameroon; Diffa region in Niger; and the Lac and Hadjer-Lamis provinces in Chad). Following the adoption of the adjusted RS SRR, the TAPs need to be updated, and a new results framework (RF) developed. An international consultant has been recruited to lead and guide the process of updating the TAPs and developing the results framework. As such, the LCBC is recruiting four national consultants (one per country) to support the principal consultant with all engagements related to the update of the TAPs and RF, at the territorial and national levels.

The deadline for the submission of all proposals is 24th of March 2025.**

Submissions will be reviewed in accordance with LCBC procedures.
